### 4.1 Description of first aid measures

#### Inhalation

Remove source of exposure or move person to fresh air and keep comfortable for breathing. If unwell, or exposed and concerned: Get medical advice/attention.

#### Eye Contact

Rinse eyes cautiously with lukewarm, gently flowing water for several minutes, while holding the eyelids open. Remove contact lenses, if present and easy to do. Continue rinsing for a flushing duration of 15-20 minutes. Take care not to rinse contaminated water into the unaffected eye or onto the face. #### Skin Contact

Take off contaminated clothing, shoes and leather goods (e.g. watchbands, belts). Wash with plenty of lukewarm, gently flowing water for a duration of 15-20 minutes. ### 5.1 Extinguishing media

#### Suitable Extinguishing Media

Small Fire : Dry chemical, foam, carbon dioxide, water-spray or alcohol-resistant foam. Carbon dioxide can displace oxygen. Use caution when applying carbon dioxide in confined spaces. Large Fire : Water spray, fog or alcohol-resistant foam.

#### Unsuitable Extinguishing Media

### 5.3 Advice for firefighters

#### Fire-Fighting Procedures

Isolate immediate hazard area and keep unauthorized personnel out. Stop spill/release if it can be done safely. Move undamaged containers from immediate hazard area if it can be done safely. Cool containers with flooding quantities of water until well after fire is out. Caution should be exercised when using water or foam as frothing may occur, especially if sprayed into containers of hot, burning liquid. Dispose of fire debris and contaminated extinguishing water in accordance with official regulations.

## SECTION 6) ACCIDENTAL RELEASE MEASURES

### 6.1 Personal precautions, protective equipment and emergency procedures

#### Emergency Procedure

If spilled material is cleaned up using a regulated solvent, the resulting waste mixture may be regulated.

#### Recommended Equipment

## 6.2 Environmental precautions

## 6.3 Methods and materials for containment and cleaning up

## 7.1 Precautions for safe handling

### General

## 8.2 Exposure controls

### Eye Protection
